

General Terms and Conditions for the European Marantz Challenge2025

1. General

- 1.1 This European Marantz Challenge 2025, hereafter referred to as 'challenge', is organized by D&M Europe B.V. (Marantz) and is valid from 15 October 2025 to 31 December 2025.
- 1.2 The challenge is only valid for selected D&M Europe B.V. business contacts within the European Union.
- 1.3 Participation in the challenge is by invitation of D&M Europe B.V. only.
- 1.4 By participating in the challenge, the participant declares to agree to these general terms and conditions.

2. Participation

- 2.1 Participation is at your own risk. D&M Europe B.V. shall not be liable for any damage, loss or expenses arising from participation in the challenge.
- 2.2 Participants submit the material required for scoring via the website www.europeanmarantzchallenge2025.com. Other methods of submitting material will not be accepted.

3. Challenge period and Selection process

- 3.1 The challenge will run from 15 October 2025 to 31 December 2025. Submission of material regarding the challenge period. is allowed up to and including 15th of January. Submissions after this period will not be considered.
- 3.2 D&M Europe B.V. reserves the right to exclude participants if they do not comply with the conditions.

4. Winners

- 4.1 The winners of the Challenge will be selected based on their final scores, as evaluated by a judging panel appointed by D&M Europe B.V. Participants from the following six regions will take part in the Challenge: United Kingdom & Ireland, Belgium & Luxembourg, Spain & Portugal, France, Germany and The Netherlands. All participants across these regions will be grouped into six (6) tiers based on predefined criteria. One grand prize winner will be selected from each tier, resulting in a total of six (6) grand prize winners.
- 4.2 D&M Europe B.V. will notify winners no later than 31 January 2026.
- 4.3 Awarding of the prizes will take place in the first quarter of 2026.
- 4.4 Winners must respond within 14 days of the announcement of their winnings. If they fail to do so, D&M Europe B.V. reserves the right to designate another winner.
